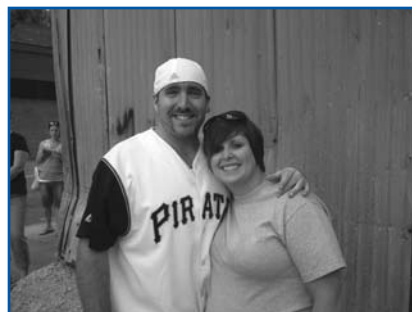
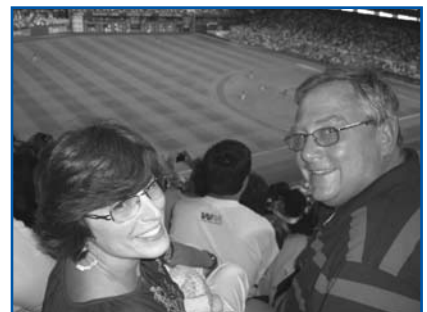
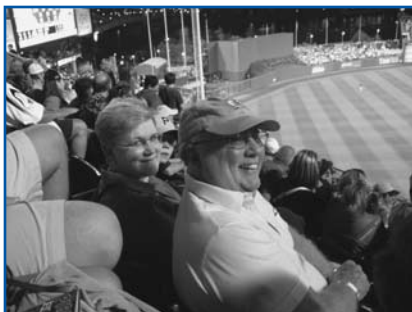
CHAMPION LAKES GOLF OUTING

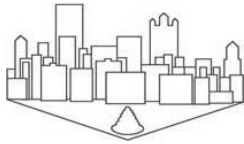

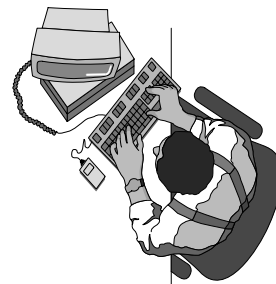

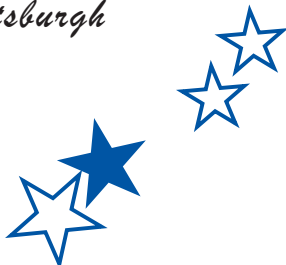
